Review the handbook to discover the areas that interest you and then check due dates and deadlines. A helpful hint: Don't wait until the last day! If have any questions about your entry or how to enter, come by the office or give us a call and will be happy to take the time to help you.

At the Beginning of each Department you will see:

**ENTRIES DEADLINE:** Date and time entries close. Complete the entry either online at [tehamadistrictfair.com](http://tehamadistrictfair.com) or via the paper entry form and pay any applicable entry fees before the due date.

**ENTRY FEE:** Look at the beginning of each Department for the required entry fee.

**ENTRIES RECEIVED:** The date Livestock should be brought onto the Fairgrounds.

**ENTRIES JUDGED:** This is the date and time of Market Animal Grading.

**Entry Office Hours:** Monday thru Friday 9:00 AM to 12:00 PM; 1:00 PM to 3:00 PM

Hours will change to 9:00 AM to 5:00 PM as Fair approaches

# COVID-19 REGULATIONS

Due to the uncertainty of changing COVID-19 Regulations the Exhibitor Handbook will serve as a guide for exhibitors, however the Tehama District Fair Board of Directors reserves the right to change entry deadlines, grading classes, sale platforms, and any other necessary details in order to ensure that exhibitors may sell their market animals.

## Changes This Year

- Exhibitors will need to submit a picture of them in uniform, with their market project for the online portion of the Junior Livestock Auction. *Buyers will see this photo.*
- Exhibitors may take poultry as a market project.
- Buyers will be able to attend the Junior Livestock Auction in person or bid online.
- Should COVID-19 regulations become more stringent the Junior Livestock Auction and Evaluation will follow a similar process as 2020 with an online evaluation and auction.

## Dates to Remember

**December 30th- Steer Tags Due:** All market steer exhibitors must submit a hair sample and picture of them with their tagged steer by 5:00PM to the Fair Office.

**February 28th- Hog, Sheep, and Goat Tags Due:** All market hog, sheep, or goat exhibitors must submit a hair sample and picture of them with their tagged animal by 5:00PM to the Fair Office.

**March 29th- Meat Poultry and Rabbits Ownership Deadline:** All meat rabbit and poultry exhibitors must have their projects.

**April 9th- Entries Due:** All Livestock Entries due online at - [www.tehamadistrictfair.com](http://www.tehamadistrictfair.com) by midnight.

# LOCAL RULES AND REGULATIONS

## STATEMENT OF EXHIBIT PRINCIPLES

The Division of Fairs and Expositions believes the mission of competitive exhibits at fairs is to ensure the competition is educational, ethical, and equitable. This will be accomplished in a manner representing the highest integrity and standards of all participants.

Upon submittal and signature of the entry form, exhibitors (Including Agents and Junior Exhibitors' Parents/Leaders/Advisors) acknowledge and agree to the following principles for competition.

1. Exhibitors will comply with printed fair and State Rules, and accept all responsibility for their exhibitors.
2. Exhibitors will indemnify Fairs & Expositions and the fair from any loss resulting from rules enforcement.
3. Exhibitors must be able to prove their own eligibility and that of their exhibits according to fair rules and acknowledge that misrepresentation of any kind is prohibited.
4. Junior Exhibitors are expected to prepare, manage, and present their own exhibits.
5. Exhibitors will conduct themselves with sportsmanship, integrity and cooperation with all participants.
6. In the case of animals:
  - A. Exhibitors will exhibit health animals and handle them with care; and
  - B. Exhibit them in their unaltered conformation, except for common husbandry practices; and
  - C. Use all pharmaceuticals, biologics and other chemicals lawfully and with notification to fair management as it specifies.

IN FULFILLMENTS OF ITS RESPONSIBILITIES, Fairs and Expositions and the fair agree to the following principles for competition:

1. The Fair will advocate and enforce printed rules.
2. In case of rule violations or in practices determined to be unethical with the competitive exhibit program,
  - A. The fair has the right to deny entry or remove any exhibitor or exhibit that is determined ineligible, or whose presentation is deemed not in the best interest of the fair, endangers the public, or has violated the rules;
  - B. The fair shall discipline such exhibitors as deemed appropriate; and
  - C. The fair shall submit a written report of such discipline to the appropriate governing body of the Divisions of Fairs, regulatory agency, youth or breed association.
3. Fair staff will conduct themselves with integrity, professionalism and cooperation with all participants.

**NOTE: All rules contained in the "State Rules for California Rules" as prescribed by the Division of Fairs & Expositions apply to this Fair. Copies of this booklet may be obtained at the Fair Office, or on the Division of Fairs & Expositions' website "[www.cdfa.ca.gov/fe](http://www.cdfa.ca.gov/fe)" Please read these rules as YOU are responsible for them,**

1. **PLEASE READ CAREFULLY** all rules and regulations since **important changes** have been made. If rules are not complied with premium awards shall be withheld.
2. **Entry Forms:** Entry Forms may be obtained online on the Fair's website, [www.tehamadistrictfair.com](http://www.tehamadistrictfair.com).
3. Fair Management is not responsible for any errors in entries. **Management or any judge reserves the right to modify Division Requirements at their discretion.**
4. **Judging System:** All Divisions will be judged under the American System as listed per division. No Exhibitor shall receive more than two cash awards under the American System. Ribbons will be awarded as placed.
5. **Premiums:** Premium checks will be available in the Fair Office Monday, May 3rd.
6. **Placing:** It is possible to move or relocate ribbons, the placing on the judging sheets will be used as the official placing. Not the color of ribbon affixed to the exhibit.
7. **Animal Arrival:** All livestock must be in place and on the grounds by Wednesday, April 28th at 7:00 PM. Please enter through the Trinity Gate. Poultry must go through inspection first before going to the poultry barn.
8. **Substitutions:** Substitutions can only be made within a division. Substitutions must be made when the exhibit arrives at the Fairgrounds, or for livestock, when registration certificates are checked. See State Rule Book, General Rules II Entry Process.
9. **Hours:** Grounds are open to the public from 7:00 AM until 12 Midnight.
10. **Vehicles:** All vehicles must be removed from the grounds by 10:00 PM on April 28th. All stock trailers are to be parked in the south east corner of the Trinity Parking Lot. Vehicles are NOT allowed in any of the camping areas.
11. **Refunds:**
  - Refunds may be made only because of animal's sickness, accident, death, cancellation of a class, or return of entries due to lack of exhibit space.
  - Non-selected animals in a juried show are not eligible for refunds.
  - For animal classes, request must be made in writing prior to the event. Requests involving health or soundness of an animal must be accompanied by a veterinarian's certificate.
12. **No Soliciting,** other than authorized concessions, will be permitted on the grounds.
13. **No Skateboards, Scooters, Motorized Bikes, or Bicycles allowed on the Fairgrounds.**
14. **Fire Marshall:** The State Fire Marshall shall check all booths in regard to fire hazards. Flammable materials may not be used and no blocked exits.
15. **No Dogs** will be allowed on the Fairgrounds. Guide Dogs and Guide Dogs in training must be properly identified to be exempt from this ruling.

16. **Loss or Damage:** The Board of Directors will not be accountable for loss or damage. Exhibitors must give attention to their animals during the Fair.
17. **For Sale Signs** are not allowed to be posted in any area of the Fairgrounds, including Livestock and Horse Departments.
18. **Supervision of Junior Livestock Exhibitors**
  - Adult supervisors are required for all overnight exhibitors.
  - Junior Exhibitors who, in the opinion of Fair Management, fail to conform to acceptable standards of conduct will be removed immediately with exhibits from the Fairgrounds and all premiums forfeited.
19. **Health Check:** A health check will be conducted on ALL livestock. Livestock will be inspected for obvious evidence of any active, communicable disease, found to be unsafe, or any other unsightly disease or condition.
20. **Safe Handling:** All exhibitors must be able to safely handle and manage their livestock. Unruly animals may be released from the Fairgrounds, all premium and sale privileges forfeited.
21. **Registration Papers:** All registration papers must be checked by 7:00 PM Wed., April 28th. All Livestock must be on grounds by 7:00 PM Wed., April 28th.
22. **Absence Excusal Review:** The legal owner must show and sell his/her own animal in all conformation classes and the sale ring. Any exception MUST BE APPROVED in advance by the Tehama District Board of Directors.  
**Only Exhibitor's written explanations will be accepted.** Written excusal letters are to be delivered or mailed to the Fair Office no later than Friday, April 9th. Each request will be ruled upon on an individual basis during the April Board of Directors Meeting. Letters can be mailed to PO Box 70, Red Bluff, CA 96080.
23. **Bedding:** All bedding must be supplied by the exhibitor. First bedding ONLY furnished by the Fairgrounds.
24. **Clean Stalls:** Public access through the barns will not be restricted by feed, equipment, or personal belongings. Each space used by the exhibitor must be kept clean. The general appearance must be neat at all times. All stalls and pens must have clean bedding in place by 9:00 AM.
25. **Medications:** All records of medications administered during the Fair will be given to the Livestock Supervisor
26. **Independent Exhibitors** must follow all rules outlined in the Independent Exhibitor Packet.
27. **Fitting:** Junior Exhibitors are expected to groom and care for their animal(s) when at the Fair. They shall refrain from accepting assistance from adults unless the Junior Exhibitor is actively engaged, and the assistance is for instruction or safety ONLY.
28. **Showmanship:** In order to compete in showmanship exhibitors must also be entered in a confirmation or market class. Exhibitors cannot compete solely in showmanship.

29. **Premium Pay Out Breakdown:** New this year premium payouts will be Jackpot Style.

- **Junior Livestock & Horse Department:** Office charge per entry will be \$5. For example entry fee of \$15 will result in \$10 in the pot. See the breakdown below.

# TEHAMA SHASTA HORSE DIVISION

Exhibitors of horses in livestock and horse show departments will comply with the provisions of the Horse Protection Act 1970 (P.L. 91-540) and rules adopted by the United States Secretary of Agriculture to carry out its provisions.

1. **ONE DAY SHOW** for the Tehama & Shasta District Fairs
2. Use **GREEN HORSE ENTRY FORM** for halter and performance entries.
3. No more than one ownership on each entry form unless otherwise specified.
4. A drug fee of \$5.00 per horse will be charges payable with entry fee.
5. Stalls available by request at \$25.00 per stall and payable with entry fee. Number of stalls required must be on entry form. Bedding must be supplied by the exhibitor. SHAVINGS ONLY. Tack stalls available at \$25.00 per stall as space allows. Stall assignments made by Fair Management. Stallion owners must provide stall chain with snap.
6. All registration papers must be **Submitted** by 7:30 AM Saturday, April 24th.
7. Photocopies of registration certificates naming the exhibitor as the owner may be permitted for the purpose of submitting entries. However, if the Fair receives any complaint or challenge concerning the registration of any animal, the Fair may request and original registration certificate and may disqualify the entry if it cannot be produced. A copy of a notarized lease purchase contract AND a photostatic copy of the registration certificate will be accepted for horses entered in the OPEN Light Horse Division ONLY. Foals under 12 months of age and still owned by the owner/breeder can be exhibited when accompanied by the mare's registration certificate and a copy of the breeder's certificate.
8. Three entries by two or more exhibitors constitute a minimum horse show class unless otherwise specified. Show management reserves the right to return entries, transfer entries, combine divisions or classes, and/or cancel any division or class in which, in its judgement, the entries are insufficient to secure adequate competition.
9. Horses may be entered in as many classes as they are eligible. The exhibitor (owner) is still limited to two cash awards per class. Ponies entered in classes in which horses are eligible to compete cannot be shown in pony classes at the same show.
10. The age of the exhibitor on January 1st shall be maintained through the next calendar year for the Junior Mount classes only.
11. Exhibitors must be at least 18 years old to show stallions.
12. **All exhibitors under 18 years of age must wear helmets in all mounted or horse drawn vehicle events.**
13. There will be a two minute hold on the gate after the last call for the class. **THIS RULE WILL BE STRICTLY ENFORCED.**
14. Horses shown from trailers on Saturday must enter from Trinity Avenue to Gate #7, then to Gate #11.
15. Horses shown from stalls must enter Gate #7 from Trinity Avenue to Gate #11 and proceed to stalls to unload. **After unloading all vehicles and trailers must be parked in the Trinity Parking Lot.**
16. **Absolutely NO parking in the barn area.**
17. **Absolutely NO dogs allowed on grounds.**
18. Fair management may retain prize money won in this department no longer than fourteen days after the close of the Horse Show.

21. All Stalled horses must vacant the Fairgrounds by Sunday

Obstacles found in a ranch trail pattern are approximate to those found during the course of everyday work. Judges are looking for a well-trained, responsive and well-mannered horse that can correctly navigate and negotiate the course, and to do so in a correct and efficient manner.

## Division 917 - Ranch Reining

Ranch Reining measures the ability of the stock horse to perform basic handling maneuvers. What the judges are looking for in ranch reining; "To rein a horse is not only to guide him but also to control his every movement. The best reined horse should be willingly guided or controlled with little or no apparent resistance and dictated completely."

## Division 918 - Ranch Conformation

To be eligible to compete in the ranch conformation class, the horse must be shown in at least one class of the other categories the day of the show. Judges are looking for balanced, structurally correct horses with adequate muscling. You'll need to show your horse in a good working halter- rope, braided, nylon, or plain leather. Exhibit your horse at a walk and trot, then line up for inspection by the judge
